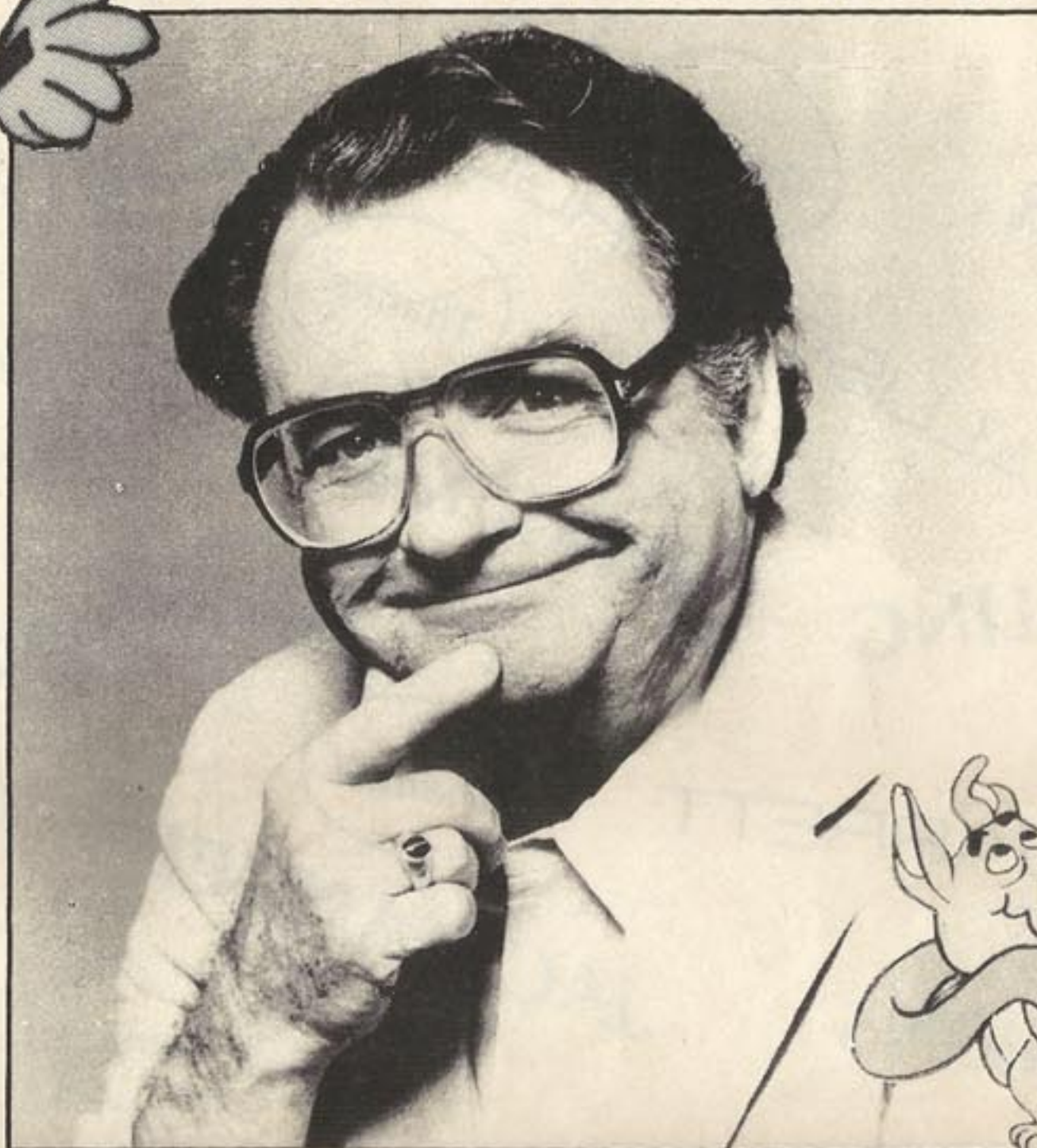





Dear Mr. Charles H. Stern:

This letter will confirm the agreement (the "Agreement") between Mr. Don Messick, represented by Charles H. Messick hereby licenses ShowBiz to use and reproduce Messick Voice Tracks as part of the Production only, and then only in conjunction with a robotic, "Animatronic", ^{Boo}Yogi Bear as entertainment on stages in showrooms of the family restaurants owned by ShowBiz (e.g., ShowBiz Pizza Place) located in Omaha, NE, Colorado Springs, CO and Augusta, GA (the "Test Restaurants") for a Test Marketing Period of twelve (12) consecutive months. The Test Marketing Period shall commence ^{within} sixty (60) days following the date of the first recording session involving Messick hereunder. The Test Marketing Period shall be divided into two (2) consecutive periods of six (6) consecutive months each, the first of which shall commence contemporaneously with the commencement of the Test Marketing Period.

c. Payment for Messick's services and the license granted hereunder shall be the greater of:

(i) Eight Hundred and Fifty Dollars (\$850.00) for each eight minute audio segment recorded by Messick hereunder; or

(ii) Eight Hundred and Fifty Dollars (\$850.00) per segment for each consecutive six (6) months or any fraction thereof that ShowBiz actually uses such segment(s) in the Restaurants.

d. Written notification will be made to Messick no later than ninety (90) calendar days prior to expiration of the Test Marketing Period regarding the decision of ShowBiz with respect to the further use of Messick's Voice Tracks by ShowBiz.

2. Miscellaneous: The following shall be applicable during both the Test Marketing Period ~~and the Regular Use Period, to-wit:~~

a. ShowBiz will be Signatory to the Aftra Non-Broadcast Industrial Material Code.

b. For purposes of use and the payment therefor, the six (6) month use period shall begin no later than sixty (60) calendar days after the date of the first recording session for a particular tape.
